Introduction

The family has great importance in society. The family is the smallest social community in which the man is born, grows up, develops and gets educated. While in the fourth chapter and the last one we discussed the legacy and its regulations in the Islamic law, pointing out that Islam gives the right in inheritance to the female also, deprivation of which this right is prohibited, as well as cases of the inability to inherit.
